### Affordable Clean Energy (ACE) Rule

- June 19, 2019 EPA issues ACE Rule
  - Provides states with new emission guidelines that will assist states in developing standards of performance to reduce carbon dioxide (CO<sub>2</sub>) emissions from existing coalfired Electrical Generating Units (EGUs).
  - Nine affected units in Kansas @ five facilities.
- Repealed the Clean Power Plan (CPP)
- Revised implementing regulations for ACE, ongoing emission guidelines, and all future emission guidelines for existing sources issued under the authority of the Clean Air Act (CAA) section 111(d).
- Initial meeting with affected sources on July 26 and second meeting scheduled for Nov. 14


#### 2019 Flint Hills Season Update



- Extensive outreach/education preburn/during season
- Uptick in burned acres because of unfavorable conditions in 2018
- Over 413,000 acres burned between March 15 and March 31
- 2 ozone and 2 PM<sub>2.5</sub> air quality exceedance days directly linked to burning
- Acres burned: 2,627,737

#### Satellite Derived Acres Burned in Flint Hills - 2018 vs. 2019



### **Monitoring Activities**

- Salina Pb (lead) Site relocation
  - Primary and Sequential sampling efforts will continue in the immediate area, but the site
    was relocated approximately 90 meters east of the current location in Salina, KS
- Glenn and Pawnee (Wichita) (PM<sub>10</sub> & PM<sub>2.5</sub>)
  - Site closed due to redundancy and major monitor failure
- Justice Center (Kansas City)
  - Filter-based PM<sub>2.5</sub> monitor has reach end of technical support from manufacturer in 2018
  - Will continue to operate site until monitor ceases operation
- Low Cost Monitors
  - Conducting a long term (year) evaluation of three low cost "Purple Air" PM<sub>2.5</sub> monitors at KNI Topeka site to test durability and operations under differing meteorological conditions
- Submitted and received approval for the 2019-20 Air Monitoring Network plan from EPA

### Planning/Regulations Activities

- Volkswagen Settlement
  - Volkswagen Funds were established as a line item in the FY2020 state budget
  - Late Summer/early Fall First funding withdrawal requests from Trustee for State DERA school bus projects
  - Second State DERA round will include school buses and off-road construction equipment
- Revenue Stabilization Project
  - Have held multiple stakeholder meetings with both Class I and Class II sources
  - \$150/ton HAP Fee, \$53/ton Criteria Fee + 1.50% yearly adjustment, "Complexity" Base Fee
- Regional Haze Planning Activities SIP due 2021
  - CenSARA completed "Area of Interest" Modeling
  - Reviewing EPA's Revised Guidance and waiting on Future Year Modeling (2028)
  - National Meeting October 28-30 in Saint Louis

- Regulatory Updates
  - K.A.R. 28-19-300 and K.A.R. 28-19-304 Construction Permits and Fees
    - Approved October 3, 2018 in Federal Register, effective Nov. 2, 2018
  - K.A.R. 28-19-720 Adopts up to July 1, 2017 NSPS
    - Approved By Attorney General
  - K.A.R. 28-19-735, 28-19-750, & 28-19-750a Adopts up to July 1, 2017 NESHAP, MACT & SOCMI Standards
    - In Internal Concurrence then External Review
- USEPA Region 7 Pending Approval:
  - K.A.R. 28-19-350 PSD Ethanol Rule Revision
  - K.A.R. 28-19-11 Enforcement discretion due to SSM
  - 2015 Ozone Standard Infrastructure State Implementation Plan (I-SIP)
- 2010 SO<sub>2</sub> "Good Neighbor" Portion of I-SIP submitted to EPA for preliminary review
